- GIVEAWAY PERIOD – Entry Period begins at 12:01 am CDST August 23, 2019, and ends at 11:59 pm CDST November 1, 2019. The Giveaway computer is the official timekeeping device for the Giveaway.
- ENTRY DEADLINES AND DRAWING DATES – One (1) winner will be selected during the week following the end of the giveaway period.
- HOW TO ENTER – To enter, (1) visit Pump & Pantry’s booth at the Nebraska State Fair in the Pinnacle Expo Building and show a valid Perks Card to be scanned for one entry, limit one entry per day per card; (2) visit Pump & Pantry’s booth at the Nebraska State Fair in the Pinnacle Expo Building and register for a new Perks Card to be scanned for one entry; (3) purchase any Dr. Pepper product in any size Fountain Drink at any Pump & Pantry with a Perks Card during the giveaway period; (4) Write your name, address and phone number on a 3x5 card and mail it to Dr. Pepper Boss Fuel Giveaway, 1607 S Locust, Grand Island, NE 68801.

- **PRIZE** – There will be one (1) winner selected from valid entries. The winner will receive five (5) Five Hundred Dollar (\$500.00) Pump & Pantry gas cards (the “Prize”) totaling a valued of \$2,500.
